Stockport's Children and Adult's Safeguarding Partnerships welcomes you to its 5th special edition COVID-19 Newsletter. It is almost two months since we began to put up with the lockdown and put up with a hard programme of social distancing in a way to only defeat the coronavirus pandemic.

On the evening of Sunday 10th May 2020 the Prime Minister announced the first introduction to a range of adjustments to current social distancing controls, timing these carefully according to both the current spread of the virus and the Government's ability to ensure safety. These changes will happen in "steps," as set out in the published [50-page document](#) that outlines the next phase of its response to the coronavirus pandemic.

## COVID-19 children's social care guidance for local authorities and social workers

At this time of national crisis, the government is seeking to ensure the protection of vulnerable children. As you'll be aware, Stockport's Children's services have been working with a variety of stakeholders and colleagues across the children's social care sector to reflect amendments to regulations in [updated guidance](#)

### The updated guidance:

- Acknowledges the need for sufficient flexibility through a set of amended regulations, **for use only when absolutely necessary.**
- Sets expectations that **risk assessment of every child, and identifying those most at risk** will be important and that **vulnerable children are encouraged to attend school**
- Covers help, protection, care and leaving care and **responds specifically to questions we have been asked about**, for example, children's homes and residential settings, unaccompanied asylum seekers, care leavers, courts, fostering, adoption, workforce and Ofsted
- Provides questions and answers to clarify queries surrounding the regulation changes

We would be grateful if you would highlight the link to the guidance to your staff, colleagues and relevant stakeholders as appropriate.

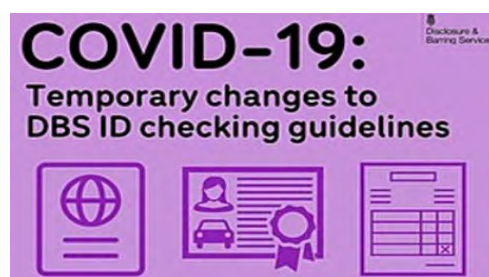

## Covid-19: DoLs, Mental Capacity and Best Interests

Stockport CCG are doing their first virtual GP briefing session with the safeguarding leads so that local GP practices continue to feel informed and engaged with safeguarding.

## Local News

### Greater Manchester Fire and Rescue Service (GMFRS)

Staff have been supporting Stockport Council by making welfare telephone calls to the vulnerable over 70s in the Stockport Borough.

The Stockport Mutual Aid Project commenced at midday on Thursday 23rd April, since then GMFRS staff have completed over 1,077 outgoing calls.

The welfare calls aimed at supporting and signposting service users onto the various COVID-19 support platforms, have been a great success so far.

## Emollients can cause deaths

There have been Safeguarding Adult Reviews within the UK as a result of fire related deaths due to emollient. Emollient skin products are widely prescribed and dispensed for various skin conditions such as psoriasis and eczema. They are safe to use but can soak into clothing, dressings and bedding leaving a flammable residue. If exposed to naked flame or heat source e.g. cigarettes, heaters etc. they could catch fire and spread rapidly which could result in serious injury or death.
